No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This proposal provides that upon receiving a valid, lawful prescription for a contraceptive, a pharmacy has a duty to dispense the contraceptive or a suitable alternative permitted by the health care provider who issued the prescription. The pharmacy must fill the prescription without delay, consistent with the normal time frame for filling any other prescription. If the contraceptive or suitable alternative is not in stock, the pharmacy must obtain the contraceptive under the pharmacy's standard procedures for ordering contraceptives not in stock.

If the patient prefers, the prescription must either be transferred to a local pharmacy of the patient's choice or returned to the patient.

This proposal also provides that nothing in the provisions of this proposal shall interfere with a pharmacist's screening for potential drug therapy problems, contraindications, or other potential interaction problems.

This proposal also provides that a pharmacy has a duty to treat each customer in a non-judgmental manner and ensure that each customer is not subjected to indignity, humiliation, breaches of confidentiality, or pressure to fill or not fill the prescription.

Violation of the provisions of this proposal shall subject the licensed pharmacy to disciplinary action.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
