FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Mental Health** and the **Office of Attorney General** assume this proposal would not fiscally impact their agency.

Officials from the **Department of Social Services - Family Support Division (FSD)** assume since this proposal is extending the sunset date, there would be no fiscal impact.

Officials from the **Department of Social Services - Division of Medical Services (DMS)** state this proposal extends the uninsured children's program (CHIP) to June 30, 2008. DMS states Section 208.631 through 208.657 has appropriation authority of \$137.7 million (\$18.8 million General Revenue, \$98.5 million Federal Funds and \$20.4 million Other funds). The DMS assumes there would be no fiscal impact since this proposal is extending the statutory authority for an existing program.

Officials from the **Department of Health and Senior Services (DOH)** assume this proposal would not fiscally impact the operations of the DOH. DOH states if a fiscal impact were to result, funds to support the program would be sought through the appropriations process.

ASSUMPTION (continued)

Oversight assumes this proposed legislation extends an existing provision by removing or changing the expiration date. Oversight assumes removing or changing the expiration date will extend any current fiscal impact associated with the existing provision. Therefore, Oversight has reflected no fiscal impact in the fiscal note.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


DESCRIPTION

This proposal extends the sunset date for the Healthcare for Uninsured Children Program from July 1, 2007 to June 30, 2008. This date corresponds to the sunset date for the state Medicaid program.
