FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Mental Health** and the **Office of Attorney General** assume this proposal would not fiscally impact their agency.

Officials from the **Department of Social Services - Family Support Division (FSD)** assume since this proposal is extending the sunset dates, there would be no fiscal impact.

Officials from the **Department of Social Services - Division of Medical Services (DMS)** state this proposal extends the uninsured children's program (CHIP) to June 30, 2008. DMS states Section 208.631 through 208.657 has appropriation authority of \$137.7 million (\$18.8 million General Revenue, \$98.5 million Federal Funds and \$20.4 million Other funds). DMS also states this proposal also extends the sunset clause for the self-directed personal care services program from June 30, 2006 to June 30, 2008. The DMS assumes there would be no fiscal impact since this proposal is extending the statutory authority for a existing programs.

Officials from the **Department of Health and Senior Services (DOH)** assume this proposal would not fiscally impact the operations of the DOH. DOH states if a fiscal impact were to result, funds to support the program would be sought through the appropriations process.

Oversight assumes this proposed legislation extends an existing provision by removing or changing the expiration dates. Oversight assumes removing or changing the expiration dates will extend any current fiscal impact associated with the existing provision. DESCRIPTION

This proposal extends the sunset date for the Healthcare for Uninsured Children Program from July 1, 2007 to June 30, 2008. This date corresponds to the sunset date for the state Medicaid program.

This proposal also extends the expiration date of the financial assistance for the Consumer-directed Personal Care Services Program until June 30, 2008.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
