## FISCAL ANALYSIS

### ASSUMPTION

Officials of the **Kansas City Manager's** office assume there would be no fiscal impact to the city.

**Oversight** assumes this proposal alters the annexation procedures that would be followed by the board of a street light district. This proposal changes the procedure from one of filing a petition with the board of a street light district, to one of being approved by the voters of the area petitioning to be annexed and by voters within the street light district. **Oversight** assumes there would be minimal cost associated with an election.

**Oversight** assumes this proposal does not mandate the annexation of street light districts, and as written would not have fiscal impact.

The proposed legislation appears to have no fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
