## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Revenue, Department of Transportation (DHT), and the Department of Public Safety - Missouri State Highway Patrol and Office of the Director** state this proposal will not have a fiscal impact on any of their respective agencies.

Officials from DHT state this provision is added to place Missouri law in compliance with 23 U.S.C. Section 127(a)(12), effective August 10, 2005, which increases the maximum weight limit and the axle weight limit for heavy duty vehicles equipped with idle reduction technology, up to 400 pounds. Pursuant to 23 U.S.C. Section 127(a)(1), no state shall be apportioned funds under 23 U.S.C. Section 104(b)(1) unless the state complies with federal weight allowances and limits.

### FISCAL DESCRIPTION


The proposed legislation appears to have no fiscal impact.
