#### FISCAL ANALYSIS

### **ASSUMPTION**

Officials at the **Department of Elementary and Secondary Education (DESE)** assume there is no state cost to the foundation formula associated with this proposal. Should the new crimes and amendments to current law result in additional fines or penalties, DESE cannot know how much additional money might be collected by local governments or the Department of Revenue to distribute to schools. To the extent fine revenues exceed 2004-2005 collections, any increase in this money distributed to schools increases the deduction in the foundation formula the following year. Therefore the affected districts will see an equal decrease in the amount of funding received through the formula the following year; unless the affected districts are hold-harmless, in which case the districts will not see a decrease in the amount of funding received through the formula (any increase in fine money distributed to the hold-harmless districts will simply be additional money). An increase in the deduction (all other factors remaining constant) reduces the cost to the state of funding the formula.

Officials at the **Department of Conservation (MDC)** assume that there is no fiscal impact from this proposal to MDC funds.

Officials at the **Office of the State Courts Administrator** and **Office of the State Treasurer** each assume that there is no fiscal impact to their departments from this proposal.

**Oversight** assumes that the amount of additional revenue to the School Moneys Fund would be unknown as it is hard to predict how many people would violate the statute. However, Oversight assumes the fiscal impact to be financially insignificant.
