## FISCAL ANALYSIS

### ASSUMPTION

According to officials from the **Department of Elementary and Secondary Education**, this proposal would change the name of the "Missouri Advisory Council on Certification for Educators" to the "Commissioner's Advisory Council on Teacher Quality". The proposal would also add two members to the council and expand the duties of the council. The two additional members would result in new costs; however, DESE does not expect the costs to be significant.

**Oversight** assumes travel and other expenses will be paid in accordance with Section 160.530.2, RSMo, and there will be no expense to local school districts. **Oversight** also assumes that expenses of the membership of the Missouri Advisory Council of Certification for Educators are being reimbursed and this proposal simply codifies that expenses of the replacement council will be reimbursed in accordance with 160.530.2, RSMo.

### FISCAL DESCRIPTION


The proposed legislation appears to have no fiscal impact.
