FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of State Courts Administrator (CTS)** assume for each circuit court judge, the costs are as follows:

Circuit Court Judge: \$113,568 per year, plus fringe benefits Court Reporter: \$51,854 per year, plus fringe benefits

The total annual cost for these new positions would be \$165,422 plus fringe benefits, and 2 FTE. The judge salary reflects implementation of the recommendations from the Missouri Citizens' Commission on Compensation for Elected Officials.

There is no appropriation in the judiciary's budget to fund the new position. Should this legislation pass, CTS would have to request a supplemental appropriation for FY 08 in the amount of \$140,699.

Oversight has adjusted the Office of State Courts Administrator's fiscal estimate to include equipment and expenses for the Circuit Court Judge and Court Reporter.

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this proposal for Administrative Rules is less than \$2,500. The SOS recognizes this is a small amount and does not expect additional funding would be required to meet these costs. However, SOS also recognizes that many such bills may be passed in a given year and that collectively the costs may be in excess of what the SOS can sustain with their core budget. Any additional required funding would be handled through the budget process.

Oversight assumes Greene County may experience increased costs with an increase in the number of circuit court judges. Oversight has reflected this increase as Unknown.

Officials from Greene County did not respond to Oversight's request for fiscal impact.
