**FISCAL ANALYSIS**

ASSUMPTION

Officials from the **Department of Elementary and Secondary Education** state this proposal will have no fiscal impact on their agency little or no impact on local school districts. There may be some printing costs associated with modification of the language; however, the modifications would not prohibit the materials from including the latest medically factual information.

Officials from the **Department of Health and Senior Services** stated there is no fiscal impact to their agency.

Officials from the **University of Central Missouri** state this proposal will have no impact on their institution or on their charter schools.

In response to a similar proposal (HB 716), officials from the **University of Missouri - St Louis** (a charter school sponsor), indicated there would be no fiscal impact.

Also in response to HB 716, officials from the **Independence School District** stated their district would have no fiscal impact, as they are currently meeting the law.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
