FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Elementary and Secondary Education** assume local school districts might incur additional printing costs to implement this proposal. In addition, depending upon the level of training required by each school district for its school employees and volunteers, there could be significant unknown costs.

Oversight assumes the policy implementation required under this proposal will be included in on-going publications and any additional printing costs would be minimal. **Oversight** also assumes the level of training will be determined by each school district according to resources available.

Officials from the following school districts assumed no fiscal impact resulting from this proposal: **Marshfield; Poplar Bluff; Parkway; Fair Grove.**

The proposed legislation appears to have no fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
