#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Department of Conservation** (MDC) stated that the proposed legislation could have a fiscal impact on MDC funds. However, MDC is unable to provide an estimated impact and will rely on DOR for fiscal impact of this legislation.

Officials from the **Department of Natural Resources** (DNR) assume this proposal would authorize an exemption from state and local sales and use tax for the cost of utilities, chemicals, and materials used to produce a product. The DNR Parks and Soils Tax Fund is derived from a one-tenth of one percent sales and use tax. Therefore, any additional sales and use tax exemption would appear to be a loss to the Parks and Sales Tax Fund. The cost of utilities, chemicals, and materials used to produce a product is unknown; however, DNR would not anticipate a significant fiscal impact from this proposal.

Officials from the **Department of Revenue**, (DOR) the **Department of Economic Development**, **Office of Public Counsel** and **Public Service Commission**, and the **City of Centralia**, assume the proposal would have no fiscal impact on their organizations. DOR did not provide an estimate of the impact on state revenues.

Officials from the **Office of Administration**, **Division of Budget and Planning** did not respond to our request for information.

Officials from **Jefferson County** stated that there are several large manufacturing firms in their county and sales tax is the primary source of county revenue. Any exemption from sales tax revenue would reduce county revenues.

**Oversight** assumes this proposal would result in an unknown negative fiscal impact on the state's General Revenue Fund and other state funds which receive sales tax revenues, and on local governments.

This proposal could decrease Total State Revenue.
