FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

Currently, "weighted average daily attendance" as used in calculating state aid is defined as the average daily attendance plus the product of .25 multiplied by the free and reduced lunch pupil count that exceeds the free and reduced lunch threshold, plus a number of other calculations. This proposal increases the multiplier of .25 to one and five tenths.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
