#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Missouri Senate** state this proposal either has no fiscal impact or minimal costs which can be absorbed by present appropriations.

Officials from the **Department of Elementary and Secondary Education (DES)** assume that depending upon the actions of the task force, DES and local school districts could have several requests for information. DES does not anticipate the impact of such requests will result in costs exceeding \$100,000.

**Oversight** assumes costs associated with data gathering to comply with information requests could be absorbed with existing resources.

Officials from the **Missouri House of Representatives** did not respond to a request for a fiscal note; however, **Oversight** assumes costs can be absorbed by current appropriations.
