## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Office of Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact to the SOS office for Administrative Rules is less than \$2,500. The SOS recognizes this is a small amount and does not expect additional funding would be required to meet these costs. However, SOS also recognizes that many such bills may be passed in a given year and that collectively the costs may be in excess of what the SOS can sustain with their core budget. Any additional required funding would be handled through the budget process.

Officials from the **Department of Elementary and Secondary Education** assume the proposal would not fiscally impact their agency.

Officials from the **Department of Public Safety - Missouri State Highway Patrol** state the Criminal Record and Identification Division assumes no more than 50 requests annually for background checks for spouses of members of the United States armed forces stationed in Missouri, who have relocated from another state and need a provisional teacher's license to assume classroom duties.

State fingerprint processing fees are \$14 and FBI fingerprint processing fees are \$24; however \$2 is retained in the Criminal Records Fund as administrative fee.

50 x \$14 = \$700 (State fingerprint fee)  
50 x \$22 = \$1,100 (passed through to the FBI)  
50 x \$2 = \$100 (retained in the Criminal Records System Fund as administrative fee)  
Total Revenue = \$1,900

**Oversight** assumes potential revenue is minimal; therefore, for fiscal note purposes only, will not reflect the revenue in the fiscal impact.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
