Bill Summary: The proposal expands the do-not-call list, prohibits the making of automated phone calls for political campaign purposes to the home phone lines of Missouri residents, and requires political phone calls to include a “paid for by” statement.

## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Corrections, Department of Public Safety – Director’s Office, Missouri Ethics Commission,** and the **Office of the State Public Defender** assume the proposal would have no fiscal impact on their agencies.

Officials from the **Office of the Attorney General (AGO)** assume any potential costs arising from this proposal can be absorbed within existing resources. AGO assumes any additional complaints about automated calls can be absorbed with existing staff. Moreover, should the AGO need to promulgate any rules to administer these proposed legislative changes, AGO can absorb these costs as well.

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Officials from the **Office of Prosecution Services (OPS)** assume this proposal would not have a significant direct fiscal impact on county prosecutors or the Office of Prosecution Services.

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year’s legislative session. The fiscal impact for this proposal for Administrative Rules is less than \$2,500. The SOS recognizes this is a small amount and does not expect additional funding would be required to meet these costs. However, SOS also recognizes that many such bills may be passed in a given year and that collectively the costs may be in excess of what the SOS can sustain with their core budget. Any additional required funding would be handled through the budget process.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
