FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Social Services** and the **Missouri Health Facilities Review Committee** each assume the proposal would have no fiscal impact on their respective agencies.

Officials from the **Department of Health and Senior Services** assume the proposal modifies the training and regulation of long-term care facility inspectors and surveyors. Based on the employees hired within the last year, Division of Regulation and Licensure estimates that two surveyors hired by Health Services Regulation and ten hired by the Section for Long Term Care Regulation annually would have no long-term care work experience and would be required to observe facility operations for two days (16 hours).

12 staff X 16 hours = 192 hrs. This equates to nine percent of one FTE (192 hours/2,080 work hours per year). This will not result in any cost by the Department, as the fiscal impact resulting from the additional training requirements will be absorbed with existing resources.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
