FISCAL ANALYSIS

ASSUMPTION

Officials from the Office of the Attorney General, Department of Agriculture, Coordinating Board for Higher Education, Office of Administration – Division of Budget and Planning, – Administrative Hearing Commission, Governor's Office, Department of Economic Development, Department of Elementary and Secondary Education, Department of Mental Health, Department of Natural Resources, Department of Health and Senior Services, Department of Labor and Industrial Relations, Department of Revenue, Department of Social Services, Department of Public Safety – Director's Office, – Division of Fire Safety, – Missouri State Water Patrol, – Missouri State Highway Patrol, Missouri Consolidated Health Care Plan, Missouri Ethics Commission, Department of Conservation, Missouri House of Representatives, State Auditor's Office, City of Columbia, Clinton County, City of Centralia, City of West Plains, Kansas City Metropolitan Community College, Linn State Technical College, University of Central Missouri, Boone County Sheriff's Department, and the Springfield Police Department assume the proposal would have no fiscal impact on their agencies.

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Officials from the **Department of Transportation (MoDOT)** assume the exception in § 610.021(1) allows closing records relating to an action or cause of action involving the public body. "Cause of action" has long been defined in case law to mean a claim but did not require that a lawsuit already be filed, i.e., cause of action meant potential litigation.

In Tuft v. City of St. Louis, 936 S.W.2d 113 (Mo. App. E.D. 1997), the Court found that in the context of the SSL, cause of action included potential litigation if there was a substantial likelihood that litigation may occur and there was a clear nexus between the document sought and the anticipated litigation. The Court noted that if cause of action was not read this way, it would have a chilling affect on the ability of public bodies to settle cases before expensive litigation and expenses are incurred.

This section overrules Tuft and provides a cause of action only when a lawsuit has been filed or a party has made a demand saying litigation will be filed unless the demands are met. This significantly broadens what records would be open and unless a formal demand has been made with litigation threatened or a lawsuit already filed, records will be open although the department knows a suit is soon to be filed.

ASSUMPTION (continued)

MoDOT assumes any fiscal impact would be minimal.

Officials from the **Office of Prosecution Services** assume the proposal would not have a significant direct fiscal impact on county prosecutors or the Office of Prosecution Services.

Officials from the Greene County Sheriff's Department, Jackson County Sheriff's Department, St. Louis County Police Department, Columbia Police Department, Kansas City Police Department, and the St. Louis Metropolitan Police Department did not respond to Oversight's request for fiscal impact.
