FISCAL ANALYSIS

ASSUMPTION

Officials at the **Metropolitan Community College** assume an impact of \$100,000 the first year and \$50,000 a year for each future year.

Officials at the **Truman State University** assume they are unable to determine the impact of this proposal.

Officials at the **Lincoln University** assume modest fiscal impact in the form of expenses related to creating and administering surveys, drafting and submitting annual reports, and complying with other proposed requirements.

Officials at the **University of Central Missouri** assume a cost of \$102,397 for an Ombudsman and an ad in the calendar/handbook.

Officials at the Linn State Technical College, Missouri State University, University of Missouri assume that there is no fiscal impact from this proposal.

Officials at the **Department of Higher Education** assume the duties associated with this bill could be performed with existing resources.

Oversight assumes this proposal would not fiscally impact state revenue as the costs to the Colleges to administer the new courses would be absorbed with existing resources or offset by the tuition paid by the students.
