FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Elementary and Secondary Education (DESE)** assume this proposal appears to allow open enrollment of students in charter schools. For instance, if a charter school application was submitted by a district (and that district intended to serve a student population with at least 30% of its students with previously existing individualized education programs (IEP) the charter could do so and enroll students with existing IEP's from surrounding areas.

This proposal increases the number of institutions available to sponsor, allowing for any community college whose service district includes any part of such district and allowing any public or private four-year college or university with its primary campus in the state of Missouri.

DESE will need a total of three FTEs (two supervisors and one accounting specialist) to process applications and provide sponsor oversight.

The impact on school districts is unknown; a school district's loss of state aid for a student who moves to a charter school might or might not equal the school district's costs to educate that student that requires special education services.

Oversight assumes that it is unknown how many entities, if any, that are eligible to sponsor charters would opt to do so. Oversight assumes existing resources can be used to process applications and provide sponsor oversight. If a significant number of eligible entities would elect to sponsor charter schools, funding for personal services could be requested through the budget process.

Officials from the **Special School District of St Louis County (SSD)** estimate an annual reduction in funding of \$6.4 million to \$10.6 million between SSD and the 23 component districts in St Louis County.

Officials from the **University of Missouri - St Louis**, a charter school sponsor, responded but made no comment regarding the fiscal impact of the proposal.

Officials from the Kansas City Metropolitan Community College, Lincoln University, and Missouri State University stated this proposal would have no fiscal impact on their respective institutions.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

Current law provides that charter schools may be operated only in the St. Louis City or Kansas City school districts. This proposed legislation allows a charter school to be operated in any school district when a school's proposed charter specifies a student enrollment of at least 30% students requiring special education services as part of an individualized education program. In addition, such a charter school may enroll nonresident pupils who submit timely applications.

FISCAL DESCRIPTION (continued)

This proposal allows a community college whose service area includes any portion of a school district in which a charter school may be operated to be a sponsor. Any public or private four-year college or university with its primary campus in Missouri and with an approved teacher preparation program may sponsor a charter school.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
