FISCAL ANALYSIS

ASSUMPTION

Officials from the **Attorney General's Office** assume no fiscal impact to their agency.

In response to HCS for HB 250, officials from the **Department of Conservation (MDC)** assume this proposed legislation restricts the ability to determine the appropriate types of public use that may be allowed on public land by giving preference to equestrian use based on historic use or future development of any trails on state lands. This preference appears to be without regard to other types of public uses, security on an area, changing land use and public demands, public safety, development, operation and maintenance costs, and related authorities associated with state and federal agencies, management agreements, and outside funding arrangements resulting in possible refunds of past grants. The long-term costs associated with implementing this legislation would be substantial.

Oversight assumes this proposal allows access to riding horses or mules on trails and roads that are currently in use and maintained by the state for this purpose. **Oversight** assumes the fiscal impact of this proposal is \$0.

Officials with the **Department of Natural Resources (DNR)** assume this proposal assures access to public land owned, managed, or funded by the state of Missouri for horse and mule use on trails that are currently designated by the state as land upon which horses or mule scan be ridden.

The DNR would not anticipate a direct fiscal impact from this proposal

Parks lands are designated for different purposes and uses. Through classification the department is able to accommodate different kinds of user groups, and locate them where the impacts and maintenance may be best managed.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

The act prohibits the denial of access to trails and roads on state-owned or state-managed public land for the purpose of riding a horse or mule when equestrian use has been up to that point a permissible use on such trails or roads. The act allows such trails or roads to be closed to equestrian use only when conditions are determined not suitable due to public safety, necessary maintenance, or conflict with the mission of the land-managing agency. In such cases, a sign must be posted at the trailhead stating the cause and estimated duration of the closure.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
