FISCAL ANALYSIS

ASSUMPTION

Officials from the **Missouri Department of Transportation** and **Missouri House of Representatives** assume the proposal will have no fiscal impact on their organizations.

Officials from the **Missouri Senate** state the first full year of the appropriation (FY 05) for this committee included over \$90,000 in funding for the Inspector General position and support staff. Funding for the position was removed for FY 09 and only \$20,000 remains in the appropriation for the other support staff and the expenses of the committee. Therefore, based on the FY 09 appropriation, the Missouri Senate assumes a savings to General Revenue of \$0 - \$20,000 if the proposal is adopted.

Oversight notes earlier reductions in appropriations removed the funding for the Inspector General and associated staff positions. The remaining appropriation is related to other support staff and expenses of the Joint Committee on Transportation Oversight. Therefore, **Oversight** assumes the proposal will have no fiscal impact on the General Revenue Fund.
