FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Elementary and Secondary Education (DESE)** assume the proposal would prohibit students from testing out of the personal finance requirement. It is unclear whether this prohibition would extend to embedded curricula in another class. If embedding is no longer an option, then there could be significant impact on school districts that have chosen to embed this content in another course whether a semester course or a year-long course. School districts would be forced to rearrange their scheduling, teachers, classes, and to potentially purchase new textbooks. DESE does not know how many districts are allowing "testing out" or embedding.

Oversight assumes since the personal finance requirement which was approved in October, 2005 by the State Board of Education is already in place, this proposal codifies the requirement as well as provides an option of completing the course offered through the virtual school. **Oversight** assumes a minimum number of students currently opt to test out of the course. Based on responses from school districts, **Oversight** assumes no fiscal impact to school districts.

Officials from the **Blue Springs School District** state they already comply with the provisions of this proposal.

Officials from the **Fair Grove School District** state this proposal will have no fiscal impact on their district.

Officials from the **Marshfield School District** state this proposal will have no fiscal impact on their district. In response to an identical proposal from last year (SB 1232 - FN 5284-02), officials stated their district was planning for all students to take the class and had already budgeted for another teacher for the added class in personal finance.

Also in response to SB 1232 from last year, officials from the **Francis Howell School District** stated it was unlikely that a student could test out of the course, given the requirements. They were not aware of any student who had tested out of the course. They stated there would be no fiscal impact, since they already provide the instruction to all students.

Officials from the **Poplar Bluff School District**, in response to SB 1232 from last year, stated the proposal would have no fiscal impact on their district.
