emergency personnel, or probation and parole officer in the first, second, or third degree to include a transit operator or a metro vehicle operator while on duty or in operation of his or her official vehicle and expands the crime of tampering with a judicial officer to include juvenile officers or deputy juvenile officers, drug court commissioner-judges, family court

commissioner-judges, and administrative law judges.

#### FISCAL ANALYSIS

#### ASSUMPTION

Officials from the **Department of Transportation**, **Department of Public Safety** – **Missouri State Highway Patrol**, and the – **Director's Office** assume the proposal would have no fiscal impact on their agencies.

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Officials from the **Office of Prosecution Services** assume the proposal would have no measurable fiscal impact the Office of Prosecution Services or county prosecutors.

Officials from the **Department of Corrections (DOC)** state this proposal revises assault of a law enforcement officer, emergency personnel, or probation and parole officer in the first, second, and third degrees by adding transit operators and metro vehicle operators. Existent penalty provisions, the component of the bill to have potential fiscal impact for DOC, is for up to a class A felony. The proposal also revises tampering with a judicial officer by adding juvenile officers, deputy juvenile officers, drug court commissioner-judges, family court commissioner-judges, and administrative law judges. Existent penalty provisions, the component of the bill to have potential fiscal impact for DOC, is for up to a class A felony.

DOC officials assume offenders charged with any of the assault of a law enforcement officer, emergency personnel, or probation and parole officer crimes outlined in this proposal could already be charged and prosecuted pursuant to current statutes for assault.

DOC records indicate 1 prison opening and 1 probation opening for tampering with a judicial officer in FY07 and there were 0 in FY08.

Currently, the DOC cannot predict the number of new commitments which may result from the expansion of the offense(s) outlined in this proposal. An increase in commitments depends on the utilization by prosecutors and the actual sentences imposed by the court.

#### ASSUMPTION (continued)

If additional persons are sentenced to the custody of the DOC due to the provisions of this legislation, the DOC will incur a corresponding increase in direct offender cost either through incarceration (FY08 average of \$15.64 per offender, per day or an annual cost of \$5,709 per inmate) or through supervision provided by the Board of Probation and Parole (FY08 average of \$2.47 per offender, per day or an annual cost of \$902 per offender).

The need for capital improvements is not anticipated at this time. It must be noted that the cumulative effect of various new legislation, if passed into law, could result in the need for additional capital improvements funding if the total number of new offenders exceeds current planned capacity.

In summary, supervision by the DOC through probation or incarceration would result in additional unknown costs to the department. Eighteen (18) persons would have to be incarcerated per each fiscal year to exceed \$100,000 annually. Due to the narrow scope of this new crime, it is assumed the impact would be less than \$100,000 per year for the DOC.

Officials from the **Office of the State Public Defender (SPD)** did not respond to Oversight's request for fiscal impact. However, in response to a previous version of the proposal (Perfected HB 116, LR # 0694-01), officials assumed increasing penalties on existing crimes, or creating new crimes, will require more SPD resources. While the number of new cases (or cases with increased penalties) may be too few or uncertain to request additional appropriations for this specific bill, the SPD will continue to request sufficient appropriations to provide competent and effective representation in all its cases.

**Oversight** assumes the Office of the State Public Defender (SPD) could absorb the costs of the proposed legislation within existing resources. Oversight assumes any significant increase in the workload of the SPD would be reflected in future budget requests.
