## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **City of Kansas City** assume this proposal would have a negative impact on the city. The proposal would cost the city approximately \$144,000 per year. According to the City of Kansas City there are two cameras at thirty intersections at a cost of \$4,800 per intersection.

**Oversight** assumes this proposal as written is enabling legislation and would require action by the county's governing body or by citizen petition with voter approval before fiscal impact would be realized. **Oversight** assumes no state or local fiscal impact.

Officials from the **Office of State Courts Administrator, St. Louis County Government** and **Department of Corrections** assume there will be no fiscal impact to their agency.

### FISCAL DESCRIPTION


The proposed legislation appears to have no fiscal impact
