#### FISCAL ANALYSIS

### **ASSUMPTION**

Officials from the **Office of Administration (COA) - Administrative Hearing Commission** assume the proposal will not fiscally impact their organization.

Officials from the **COA** - **Division of Facilities Management, Design and Construction** (**DFM**) assume this bill would require the DFM to request legislation for the Capitol Improvement Funds (CI Funds) and House Bill 13 funds. Funds will be needed to study the situation of the stacked offices in the Capitol and additional funds, depending on the outcome of the study, will be needed to completely renovate the Capitol to make offices accessible to individuals with disabilities and/or relocate some offices to rental space that can not meet the accessibility needs. This would increase the funds needed for House Bill 13 for additional rental space. Some office may need to be moved to temporary office space for renovations to take place.

The DFM estimates FY 10 costs for the case study to be over \$100,000; FY 11 costs for the preliminary estimate for the design and administration are estimated to be \$5,000,000; and the FY 12 preliminary estimate for the renovation is over \$45,000,000. COA-Information Technology Services Division (ITSD) would also need to be included in the study to determine their needs associated with this renovation.

**Oversight** assumes this proposal would increase the amount of general revenue needed for the CI bill and HB13 due to the renovations required by this proposal. However, **Oversight** recognizes that it is impossible without further study to determine how the two funds would be effected. As a result, all costs are charged to the General Revenue Fund.

Officials from the **Missouri House of Representatives (MHR)** state this proposal would require renovation of numerous offices within the Capitol Building. It is assumed that all major construction expenses, including the telephone and other communication costs, relation of staff, etc., would be assumed the COA - DFM. It is anticipated that the direct impact to the MHR would be minimal and could be absorbed with existing resources.

Officials from the **Missouri Senate** state the proposal would require all offices of elected officials in the state capitol building to be accessible to individuals with disabilities by the end of 2014. It is assume that the expense for such renovation/modification would be borne by the Office of Administration. This proposal would either have no fiscal impact as it relates to the Missouri Senate or minimal costs which can be absorbed by present appropriations.
