Oversight sent response requests to the Kansas City Manager's Office and the Kansas City Police Department. No response was submitted.

Officials from the **Office of State Courts Administrator** assume there will be no fiscal impact to their agency.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.


