FISCAL ANALYSIS

ASSUMPTION

Officials from the **Boone County Sheriff's Office**, **St. Louis County**, **Office of State Courts Administrator** assume there will be no fiscal impact to their agency.

Officials from **Cass County** assume they would see a fiscal impact with this proposal. Associate Circuit judges make around \$109,000. Their sheriff currently makes \$65,000. To reach the 85% mark, Cass County would have to increase the sheriff salary approximately \$27,000.

Oversight assumes this proposal could have a fiscal impact to local government depending on the increase in the sheriff's salaries in the proposed percentages as outlined in the proposal. The amount of costs would be unknown and would depend on the county's classification. **Oversight** will show fiscal impact to local government for zero to unknown costs depending on the current salary of the sheriff and if a percentage is necessary to increase the salary amount.
