#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials at the Department of Labor and Industrial Relations, Department of Corrections, Department of Public Safety' Director's Office, Missouri Department of Conservation, Office of the State Treasurer, Department of Health and Senior Services, Office of the Attorney General and the Office of the State Courts Administrator assume that there is no fiscal impact from this proposal.

Officials at the **Department of Labor and Industrial Relations** did a search of the Division's computer system which showed that over the three year period 2006 to 2008 there was an average of 2 deaths of the occupations firefighter and volunteer firefighter. Additionally, there was 1 death of the occupation nurse. The Division was unable to determine through its injury and fatality coding system whether any deaths for the occupations air ambulance pilots or air ambulance nurses occurred in the line of duty as defined in the bill. This number also does not include any deaths where the occupation may have been coded in error when reported to the Division, but that may be eligible for the benefit provided for in the bill.

**Oversight** assumes that during the three year period reviewed 3 people could have filed a claim under this proposal. Oversight assumes that the actual number of people killed during that time was likely greater. Oversight has shown in this fiscal note that the amount paid out yearly from the Line of Duty Compensation Fund would be "unknown greater \$75,000".

Officials at the **Missouri Highway Patrol** assume the first trooper who died in the line of duty was in 1933. To date, there have been 28 total, 9 of those occurring since 1999. Something like this is impossible to predict, but if the Patrol were to take the average of the past 9 years, there has been approximately one trooper per year who died in the line of duty. Based solely on that average, the cost of this legislation would have been approximately \$25,000 per year. For purposes of this fiscal note, that would be our estimate for future years as well.

Officials at the **Department of Natural Resources** assume they have 48 full-time rangers and 2 commissioned facility managers who could be affected by this proposal. The fiscal impact would be unknown, as this would depend on the number of law enforcement killed in the line of duty. The Division's maximum potential liability would be \$1,250,000 as a result in any given year.

## ASSUMPTION (continued)

Officials from the **Office of the Secretary of State (SOS)** state many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

**Oversight** assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.

#### FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

#### FISCAL DESCRIPTION

This proposal would establish the Line of Duty Compensation Act which would allow a claim to be filed with the Division of Workers' Compensation within the Department of Labor and Industrial Relations on behalf of a law enforcement officer, emergency medical technician, paramedic, air ambulance pilot and nurses or firefighter who was killed in the line of duty. The claim must be filed no later than one year from the date of the death by the spouse, dependent, or other specified person. The amount of compensation for the claim would be \$25,000, subject to appropriations.

The provisions of the bill would expire six years from the effective date. This bill contains an emergency clause.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
