### ASSUMPTION

Officials from the **Department of Elementary and Secondary Education** state this proposal will have no fiscal impact on their agency or on local school districts.

Officials from the **Francis Howell School District** state this proposal will have no fiscal impact on their district.

In response to similar legislation from last session, (SB 911 - FN 3525-01), officials from the **Poplar Bluff** and **Independence School Districts** assume no fiscal impact on their respective districts.

The proposed legislation appears to have no fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
