FISCAL ANALYSIS

ASSUMPTION

The **Joint Committee on Public Employee Retirement (JCPER)** has reviewed this proposal and has determined an actuarial study is not needed under the provisions of section 105.660, subdivision (5).

Officials from the **Missouri State Employees' Retirement System** assume if MOSERS receives the individual employee and MDFB employer contributions as outlined in the legislation, and provided MDFB pays the expected first year contributions of \$72,495 and future contributions at the actuarially determined rate for all MOSERS participants, there would be no fiscal impact on MOSERS.

FISCAL DESCRIPTION

This act makes certain employees of the Missouri Development Finance Board members of the Missouri State Employee's Retirement System (MOSERS). These employees may purchase credited service for any period of employment as an employee of the board prior to August 28, 2009. Employees may decide whether to transfer their individual account balance under the board's plan to MOSERS. If necessary to pay for the employee's credit service, the board will be required to pay contributions to MOSERS.
