FISCAL ANALYSIS

ASSUMPTION

Officials from the **City of Kansas City**, the **Department of Public Safety**, **Office of the Director** and **Missouri Water Patrol** assume this proposal would have no fiscal impact on their organizations.

Officials from the **Office of State Courts Administrator**, the **Missouri Highway Patrol**, and the **City of Centralia** assumed a previous version of this proposal would have no fiscal impact on their organizations.

Officials from the **Office of the Boone County Sheriff** assumed a previous version of this proposal would have a minimal one-time cost to their organization for training weekend warrant specialists to make such entries.

Officials from **Clinton County** assumed a previous version of this proposal would have a minimal cost to their organization.

Officials from the **Office of the Attorney General** assumed that any potential costs arising from a previous version of this proposal could be absorbed with existing resources.

Officials from **Cass County** assume this proposal would have no fiscal impact on their organization.

Officials from the **St. Louis County Police Department** responded to our request for information on a previous version of this proposal but did not provide an estimate of the fiscal impact.

Officials from the **Creve Couer Fire Protection District** assume this proposal would have no negative fiscal impact on their organization.

Officials from the **City of Springfield** assume this proposal would have a minimal cost to their organization, estimated at \$1000 per year. Springfield city officials stated that the larger impact would be on the Greene County Sheriff's Department but did not provide an estimate of that fiscal impact.

ASSUMPTION (continued)

Oversight assumes this proposal would have no fiscal impact to the state and that any impact to local governments would be minimal and could be absorbed with existing resources. Oversight will indicate no impact for this fiscal note.

No direct fiscal impact to small businesses would be expected as a result of this proposal.

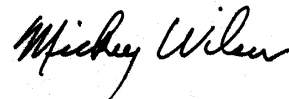
FISCAL DESCRIPTION
