FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of Attorney General, Office of State Courts Administrator, Department of Economic Development, Department of Elementary and Secondary Education, Department of Insurance, Financial Institutions, and Professional Registration, Department of Corrections, Department of Health and Senior Services, Department of Revenue, Department of Social Services, Missouri House of Representatives, Missouri Senate, Office of State Treasurer, Missouri State Tax Commission, and University of Central Missouri** assume the proposal will have no fiscal impact on their organizations.

Officials from the **Office of Secretary of State (SOS)** state the fiscal impact for this proposal is less than \$2,500. The SOS does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the SOS can sustain within its core budget. Therefore, the SOS reserves the right to request funding for the costs of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the Governor.

Officials from the **Cole County Sheriff's Department** and **County Clerks** did not respond to our request for a statement of fiscal impact.

FISCAL DESCRIPTION


The proposed legislation appears to have no fiscal impact
