FISCAL ANALYSIS

ASSUMPTION

Officials from the Office of State Courts Administrator, Department of Insurance, Financial Institutions, and Professional Registration, Missouri Department of Transportation, Missouri Consolidated Health Care Plan, Missouri Department of Conservation and Office of Secretary of State assume the proposal will have no fiscal impact on their organizations.

Officials from the **Department of Public Safety (DPS) - Director's Office** defer to Missouri Consolidated Health Care Plan for response regarding the potential fiscal impact of this proposal.

Officials from the **DPS - Missouri State Highway Patrol** defer to the Missouri Department of Transportation for response regarding the potential fiscal impact of this proposal on their organization.

Officials from the **Office of Secretary of State (SOS)** state the fiscal impact for this proposal is less than \$2,500. The SOS does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the SOS can sustain within its core budget. Therefore, the SOS reserves the right to request funding for the costs of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the Governor.

Officials from the **University of Missouri** assume the proposal will have an unknown fiscal impact on their organization.

Oversight notes the University of Missouri did not provide an explanation for their unknown impact. Therefore, **Oversight** assumes any impact will not be significant.

Oversight notes Section B of the proposal is an election clause providing that the provisions of this proposal go to a vote of the people on a regularly scheduled election day. Therefore, **Oversight** assumes the election clause has no fiscal impact.
