FISCAL ANALYSIS

ASSUMPTION

Officials from the **Missouri National Guard - Office of Adjutant General** assume there will be no fiscal impact at this time.

Officials from the **Department of Social Services state** there is no fiscal impact to their agency.

Officials from the **Department of Elementary and Secondary Education** state this proposed legislation does not impact their agency or local schools.

According to officials from the **Office of Secretary of State (SOS)**, many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the proposal. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500.

Oversight assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process. Any decisions to raise fees to defray costs would likely be made in subsequent fiscal years.

Officials from the Office of State Treasurer (STO) did not respond to a request for fiscal note. **Oversight** assumes, based on responses to other legislation that created funds in the State Treasury, there will be no fiscal impact on the STO.

The proposed legislation appears to have no fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
