#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Department of Mental Health** and the **Department of Social Services** assume no fiscal impact to their respective agencies related to this proposed legislation.

Officials from the **Department of Elementary and Secondary Education** state there is no fiscal impact to their agency and defer to local school districts regarding any potential cost associated with developing, distributing, collecting, and tracking concussions and head injury sheets on an annual basis.

Officials from the **Independence School District** state that since their district has a contract with a hospital to have trainers on site at all practices and games, they already have a plan in place and this proposal will not have a fiscal impact on their district.

Officials from the Parkway School District, Special School District of St Louis County, and the St Louis Public School District assume no fiscal impact.

In response to a similar proposal from last session (HB 1548 FN 3795-01), officials from the **Blue Springs School District**, **Sikeston School District** and the **Francis Howell School District** assumed no fiscal impact to their districts as a result of the proposed legislation.
