**ASSUMPTION**

**Section 211.447:**

Officials from the **Office of the State Courts Administrator, Department of Mental Health** and the **Department of Health and Senior Services** each assume the proposal would have no fiscal impact on their respective agencies.

Officials from the **Department of Social Services** state this legislation specifies that for the removal of custody of a child, or for the termination of parent rights, from the parent, the availability and use of accommodations for the disability, including assistive technology and support services, must be considered before a determination is made that a child is in need of care. The Children's Division does not anticipate fiscal or programmatic impact.

Officials from the **St. Louis Family Court** have not responded to Oversight's request for fiscal information.

FISCAL DESCRIPTION


The proposed legislation appears to have no fiscal impact.
