**FISCAL ANALYSIS**

**ASSUMPTION**

Officials at the **Department of Natural Resources (DNR)** assume this proposal would prohibit large water consumers from taking and transporting water from within the Southeast Missouri Regional Water District to locations outside the District, if such taking and transporting interferes with the normal water usage of certain other large water consumers. If such interference occurs, the Attorney General or the affected parties may seek an injunction. No injunction may be issued if it would harm public health or safety.

DNR assumes there is no fiscal impact from this proposed legislation.

Officials at the **Office of Attorney General (AGO)** assumes that any potential costs arising from this proposal can be absorbed with existing resources.

Officials at the **Department of Agriculture** assumes there is no fiscal impact from this proposed legislation.

**Oversight** assumes there is no fiscal impact from this proposed legislation.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
