ASSUMPTION

Officials from the **Department of Transportation** and **County of Wright** state the current proposal would not fiscally impact their agencies.

Officials from the County of Douglas did not respond to Oversight's request for fiscal impact.

Oversight assumes this proposal authorizes commissioners of road districts, upon majority vote, to provide compensation for their services of up to \$100 per month plus all expenses incurred in transacting business of the district. Oversight assumes this proposal is permissive and, by itself, would have no state or local fiscal impact.
