FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Public Safety - Missouri Highway Patrol, Office of the State Courts Administrator, and Department of Corrections** each assume the proposal would not fiscally impact their respective agencies.

Officials from the **City of Kansas City** state the proposal would not fiscally impact their city.

Officials from **City of St. Louis, St. Louis County, and Boone County** did not respond to our request for fiscal impact.

Oversight assumes the proposal simply changes the name of the Inmate Security Fund at the county level and expands the list of things that can be paid for through this fund. Oversight assumes this will not create a fiscal impact to the local political subdivisions.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.


