## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Joint Committee on Administrative Rules (JCAR)** state the legislation is not anticipated to cause a fiscal impact to JCAR beyond its current appropriation.

Officials from the **Office of Secretary of State (SOS)** state many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The Secretary of State's office is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. **The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes this is a small amount and does not expect that additional funding would be required to meet these costs.** However, it is also recognized that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain within its core budget. **Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.**

Officials from the **Department of Social Services (DSS) - MO HealthNet Division (MHD)** state MHD already has a spenddown regulation in place (13 CSR 70-4.100). Therefore, there is no fiscal impact to the MHD.

Officials from the **DSS - Division of Legal Services** assume the proposal will have no fiscal impact on their organization.

Officials from the **DSS - Family Support Division (FSD)** state the FSD assumes existing central office staff will be able to handle all actions needed to promulgate the rules required under section 208.148. Rules that are promulgated as a result of this section may have a fiscal impact and any such fiscal impact will be included with the rule's fiscal note as required by the Office of Secretary of State's rulemaking process. However, there is no fiscal impact to the FSD to promulgate the rules.

FISCAL DESCRIPTION


The proposed legislation appears to have no fiscal impact.
