FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of State Courts Administrator** state this proposal has no fiscal impact on the Courts.

Officials from the **Department of Economic Development - Public Service Commission, Division of Business and Community Services, and Office of Public Counsel** and the **Department of Insurance, Financial Institutions and Professional Registration** anticipate no fiscal impact to their respective agencies as a result of the proposed legislation.

Officials from the **Office of Administration - Division of Purchasing and Materials Management (DPMM)** stated this proposal could affect public entities and provided the following assumptions regarding this proposal:

§34.225.4 This provision will prevent DPMM from awarding a contract for goods and services in excess of one million dollars to a bidder that is a proscribed investor. Also, it would require DPMM to have all bidders certified that they are not a proscribed investor for contracts for goods and services in excess of one million dollars;

§34.225.5 DPMM would have to report to the attorney general the company's name that submitted a false certification; and,

§34.225.6 DPMM would not be able to renew a current contract after it has been determined the contractor is a proscribed investor.

In response to Perfected SCS for SB 722 (5353-05), officials from the **Office of Attorney General (AGO)** assumed this proposal would require the AGO to review information submitted by an awarding body. AGO assumed that costs could be absorbed with existing resources, but may seek an additional appropriation based on the number of submissions received for review and cases filed as a result.

Oversight assumes this proposal will not have a direct fiscal impact on entities and for fiscal note purposes only, will assign no fiscal impact.

COA-DPMM assumes this proposal could have an economic impact on small businesses that engage in investment activities in the energy sector in Iran.

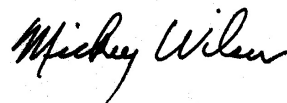
FISCAL DESCRIPTION
