FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the State Courts Administrator (CTS)** state the proposed legislation would allow circuit clerks to collect a surcharge not to exceed \$10 for processing garnishments.

Based on data for FY 2011, there are approximately 250,212 executions and garnishments on which this surcharge could be applied. CTS assumes all circuit courts would collect a \$10.00 surcharge and anticipate the revenue would be approximately \$2,502,120 in any given year.

Officials from the **Office of Administration - Budget and Planning (BAP)** state the proposed legislation should not result in additional costs or savings to BAP. The surcharges established in the legislation are local and should not impact TSR or 18e calculations.

Since clerks of the circuit courts <u>may</u> collect a surcharge <u>not to exceed</u> \$10 and based on CTS' response, **Oversight** will reflect a potential income of up to \$2.5 million per year to the local circuit clerks. Oversight will reflect ten months of impact in FY 2013.

FISCAL IMPACT - Small Business
