FISCAL ANALYSIS

ASSUMPTION

Officials at the **Missouri Gaming Commission (GAM)** assume this proposal changes how often a casino, supplier, or an individual is required to file an application for licensure with GAM. The proposal does not modify the requirement of an annual renewal fee being charged by GAM to maintain a casino operator, supplier, or individual occupation license. GAM assumes this proposal has no fiscal impact on the operations of GAM.

In response to the previous version of this proposal, officials at the **City of Kansas City** and **St. Louis County** each assumed there is no fiscal impact from this proposed legislation.

In response to a similar version, LR 4758-01, SB 580 (2012), officials at the **City of St. Louis**, **City of Maryland Heights**, and **Buchanan County** each assumed there is no fiscal impact from this proposed legislation.

Oversight assumes this proposal changes the license renewal period for gambling boat operators to every four years, but maintains the annual fee.

Oversight assumes this proposal changes the licensing renewal period to every two years for licensed occupations and suppliers related to the operations of an excursion gambling boat, but maintains the annual fee.

Oversight assumes there is no fiscal impact from this proposed legislation on state or local government funds.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
