### ASSUMPTION

Officials at the **Budget and Planning** assume this proposal prohibits certain taxpayers from receiving benefits under programs administered by the Department of Economic Development. This could increase General and Total State Revenues by an unknown amount.

Officials at the **Department of Economic Development** assume there is no fiscal impact from this proposal.

**Oversight** assumes this proposal places additional restrictions on who can qualify for economic incentives in the future and therefore will have no fiscal impact.

### FISCAL DESCRIPTION


The proposed legislation appears to have no fiscal impact.
