ASSUMPTION

Officials from the **Department of Public Safety - Alcohol and Tobacco Control (ATC)** state the proposal would not have a material fiscal impact to their agency. ATC states they will be working with the Department of Health and Senior Services and other local agencies to ensure that this proposal does not inadvertently impact public safety.

Officials from the **Department of Health and Senior Services** assume the proposal would not fiscally impact their agency.

Officials from the **Department of Revenue** state any increase in sales tax would be an unknown increase in total state revenue.

Oversight assumes the proposal prohibits the sale of this intoxicating liquor; therefore, sales tax revenue would not be impacted by the proposal.
