FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Economic Development - Public Service Commission (PSC)** assume the changes to §§376.170 and 386.180 would allow electronic publication of PSC orders, which would result in cost savings to the PSC of approximately \$10,000 per year for printing costs and the labor involved in formatting and preparing the orders for printing.

Officials from the **Department of Economic Development - Office of Public Counsel** anticipate no fiscal impact as a result of the proposed legislation.
