§§ 52.010, 54.040, and 54.330 - Affidavits for County Treasurer and Collector Candidates:

Officials from the Office of Secretary of State, St. Louis County, and the Platte County Board of Elections each assume the proposal would not fiscally impact their respective agencies.

Officials from **Boone County Collector** assume a minimal fiscal impact from this proposed legislation.

Oversight assumes this proposal requires candidates for county collector, county treasurer and county collector-treasurer to provide to the local election authority a copy of a signed affidavit from a surety company indicating the candidate's ability to meet statutory bond requirements for the office. This proposal has no fiscal impact on state or local government funds.
