ASSUMPTION

§ 60.570 - Land Survey Program Headquarters:

Officials from the **Department of Natural Resources (DNR)** state the proposal does not indicate any requirement to add signage to the building and would not anticipate a direct fiscal impact from this proposal

DNR assumes if the intent is to require some type of signage, there would be an unknown indirect costs for that signage.

Oversight assumes DNR is provided with core funding to handle a certain amount of activity each year. **Oversight** assumes DNR could absorb any costs related to this proposal.

Officials from the **Office of Administration - Division of Facilities Management Design and Construction** assume the proposal would not fiscally impact their agency.
