## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Social Services (DSS) - MO HealthNet Division (MHD)** state this legislation would allow institutions of higher education to use or occupy a portion of a hospital district to provide health care related education or training. Some hospitals are paid Graduate Medical Education (GME) funds; however, for a hospital to receive GME, the hospital must provide graduate medical education, i.e. be a teaching hospital. Before GME can be recognized by MHD, it must be approved by the Centers for Medicare and Medicaid Services (CMS). Therefore, this proposal could have a fiscal impact to MHD, but the amount is unknown. Since MHD uses the 4<sup>th</sup> prior year cost report to establish reimbursement, there would not be a fiscal impact to the MHD for the fiscal note period. However, starting in FY 17, there would be a cost, but the amount is unknown.

Officials from the **University of Central Missouri (UCM)** assume the proposal would have no fiscal impact unless cost savings eventually resulted from UCM leasing space from a hospital in proximity for less cost than the space UCM's nursing program is currently occupying. It is impossible to estimate a fiscal impact at this time.

Officials from **Metropolitan Community College** state the proposal would have a positive, although unknown, fiscal impact on the college.

Officials from **Missouri Western State University** assume the proposal would have a minor fiscal impact on their university.

Officials from the **Linn State Technical College** state the proposal would have an unknown, positive impact on Linn State.

Officials from the **Department of Higher Education (DHE)** state the proposal would have no direct, foreseeable fiscal impact on the DHE.

Officials from the **Department of Health and Senior Services, Lincoln University, Missouri State University, Northwest Missouri State University** and the **University of Missouri** each assume the proposal would not fiscally impact their respective agencies.

FISCAL IMPACT - Small Business

The proposal may negatively impact real estate businesses that lease space to colleges and universities if the universities decide to lease space from local county hospitals for health care education and training programs.

FISCAL DESCRIPTION

This proposal allows hospital districts to lease to or allow for any institution of higher education to use or occupy the hospital or any part of the hospital for the purpose of health care related education or training.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
