FISCAL ANALYSIS

ASSUMPTION

Officials at the **Jackson County Board of Election Commission**, the **Lincoln County Clerk's Office**, the **Platte County Board of Election Commission** and the **St. Francois County Clerk's Office** each assume there is no fiscal impact to their organization from this proposal.

Officials at the **St. Louis County Board of Election Commission** assume no impact as long as the Missouri election calendar remains the same.

In a previous response to this proposal, officials from the **Office of the Secretary of State (SOS)** stated many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Oversight assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.

Oversight assumes this proposal would not have a fiscal impact as appears to be clean-up language.

Officials at the following board of election commissions: Kansas City Board of Election Commission, St. Louis City Board of Election Commission and Clay County Board of Election Commission did not respond to **Oversight's** request for fiscal impact.

Officials at the following counties: Andrew, Audrain, Barry, Bates, Boone, Buchanan, Callaway, Camden, Cape Girardeau, Carroll, Cass, Clay, Cole, Cooper, DeKalb, Franklin, Greene, Holt, Jackson, Jefferson, Johnson, Knox, Laclede, Lawrence, Marion, Miller, Moniteau, Monroe, Montgomery, New Madrid, Nodaway, Ozark, Perry, Pettis, Phelps, Platte, Pulaski, Scott, St. Charles, St. Louis, Wayne and Worth did not respond to **Oversight's** request for fiscal impact.

FISCAL DESCRIPTION


The proposed legislation appears to have no direct fiscal impact.
